

No Bull Just Beer and Bikes Limited

These Conditions apply to all persons entering and making use of the no Bull site ("the Site")

1. Entry to the Site will only be authorised upon presentation of a valid ticket, pass, wrist band or accreditation issued by or on behalf of No Bull Just Beer & Bikes and, if required by No Bull Just Beer & Bikes, photographic proof of identity.
2. Ticket holders enter the Site at their own risk.
3. On arrival collect wristbands from Office they must be worn at all times there will be no re-admittance to site without a wristband.
4. We do not allow teenagers under the age of 18 years to stay at Penmaenau without parental supervision. Parents and guardians assume responsibility at all times for minors on the Site who are attending with them.
5. Proof of age will be required when purchasing alcohol on site.
6. In the event of an emergency please contact stewards at main office during office hours or at the main bar outside of office hours. When the venue is closed, please contact security personnel on site. There will be emergency contact information displayed at the main gate.
7. No child under the age of 14 allowed in the licensed area unaccompanied at any time.
8. No vehicular access or egress except in an emergency between 10pm and 8am.
9. The correct pass must be displayed at all times on the windscreen of your vehicle. Not relevant to bikes.
10. All caravans, trailer tents, and trailers will incur a £10.00 charge payable in cash on arrival.
11. Large vehicles (5m or over) in length are at the discretion of the management. Please email info@nobullbeerandbikes.co.uk
12. Blue badge holders' car/van entry is free, subject to validity checks. The charge of £10.00 for caravans still applies.
13. There are a limited number of disabled pitches available.
14. Please ensure adequate space is left between accommodation pitches and all vehicles for fire prevention and emergency access.
15. Please ensure that you have a working fire extinguisher in your caravan or tent.
16. Management reserves the right to ask anyone to leave at any time!
17. All Attendees must fully comply with the direction of authorised stewards.

18. Refunds can only be granted at the discretion of the management!
19. Drunk and disorderly behaviour may result in you being asked to leave.
20. No generators between the hours of 10pm and 8am.
21. Any Noise nuisance that is disruptive to fellow campers will not be tolerated.
22. You will only be allowed to bring alcohol onto this site if you are over 18 years of age and it is purely for your own consumption. Excessive amounts noted in vehicles or in your possession may be confiscated and returned to you on your departure.
23. It is illegal to sell alcohol to or purchase alcohol for those aged under 18. For licensing reasons Attendees aged 17 and under must stay at least 2m away from any bar or place dispensing or selling alcohol. If Attendees appear to be under 21 they will be asked for identification.
24. The following items are specifically prohibited from being brought onto the Site or made use of on the Site:
 - (a) Illegal substances;
 - (b) Open fires or equivalent devices which could potentially damage grassed areas;
 - (c) Pets and animals (other than pre-authorized guide dogs);
 - (d) Any item which may be interpreted as a potential weapon and/or compromise public safety, including sharp or pointed objects (e.g. knives, large corkscrews), 'personal protection' sprays;
 - (e) Fireworks/flares/explosives/Chinese lanterns or other pyrotechnic devices;
 - (f) Sound systems;
 - (g) Laughing gas;
 - (h) Lasers and strobe lighting;
 - (i) Psychoactive substance within the meaning of the Psychoactive Substances Act 2016;
 - (j) Gas cylinders in excess of 5Kg;
25. Visitors in possession of Prohibited Items may be refused entry or ejected from the Site.
26. If you do bring alcohol to this site, it is to remain in the confines of your tent pitch it is not to be carried around **or to be consumed in the Licensed Area's.**
27. No campfires to be made on the ground you may use barbeque trays etc., subject to weather. There will be no barbeques if the weather is very dry due to the fire hazard.

28. Photographers will be present onsite during the event. By attending the Festival, Attendees grant their permission, free of charge, for their image, likeness and voice to be included in pictures and/or on film and/or audio broadcasts or transmissions and their exploitation and advertising without compensation or credit.

Attendees acknowledge that any such use under this condition, and their agreement to such use, shall last in perpetuity

29. No Bull Just Beer & Bikes will not be responsible for any theft, damage or loss to Attendee's vehicles, equipment and personal possessions.
30. Attendees should not leave money or valuables unattended in any area of the Site
31. No Bull Just Beer & Bikes reserves the right to refuse entry to, or to eject from the Site, anyone who has tested positive for COVID-19 within 14 days of the commencement of the Festival; lives with somebody who has tested positive for COVID-19 within 14 days of the commencement of the Festival; or is otherwise required to selfisolate.
32. No Bull Just Beer & Bikes may be required to amend our Covid-19 guidelines before or during the Festival and Ticket holders must comply with all updates before, during and after attending the Festival.
33. The UK or Welsh Governments may amend their Covid-19 guidelines before or during the Festival and Ticket holders must comply with all updates before, during and after attending the Festival.
34. No Bull Just Beer & Bikes will not be responsible if Ticket Holders catch COVID-19 at the Festival or for any illness or death of any Festival Ticket Holders caused by COVID-19.
35. We do not allow dogs at our events except for guide dogs.

Limitation of Liability:

36. No Bull Just Beer & Bikes shall not be liable for the loss or damage of vehicles, goods or other materials belonging to attendees, guests, artists and crew attending the Site.
37. In no event shall No Bull Just Beer & Bikes or any of its servants agents or providers be liable for any damages whatsoever, including but not limited to any direct, indirect, special, consequential, punitive or incidental damages, or damages for loss of use, profits, data or other intangibles, or the cost of procurement of substitute goods and services, arising out of or related to the No Bull Just Beer & Bikes Festival whether such damages arise in contract, negligence, tort, under statute, in equity, at law or otherwise other than:
- (a) in any circumstances where there is a breach of a legal duty of care owed No Bull Just Beer & Bikes; or
 - (b) in circumstances where such loss or damage is reasonably foreseeable result of any such breach; and
 - (c) to the extent that any increase in any loss or damage does not arise from breach by You of any of these Terms and Conditions.
38. Notwithstanding the above nothing in these Conditions of Entry shall act to, exclude or limit our liability for death or personal injury resulting from our negligence, fraud or any other liability, which may not by applicable law be excluded or limited.

39. No Bull Just Beer & Bikes will not be responsible for any theft, damage or loss to Attendee's vehicles, equipment and personal possessions.

NO BULL JUST BEER & BIKES RESERVES THE RIGHT FOR ITS AUTHORISED EMPLOYEES, AGENTS, CONTRACTORS AND POLICE OFFICERS ACTING REASONABLY TO REMOVE FROM THE SITE (WITHOUT REFUND OR COMPENSATION) ANY PERSON WHO CONTRAVENES THE ABOVE 'CONDITIONS OF ENTRY AND TERMS OF USE AND ANY PERSON WHOSE PRESENCE AND/OR BEHAVIOUR IN THE SITE COULD REASONABLY BE CONSTRUED AS DANGEROUS, A NUISANCE OR ANNOYANCE TO ANY OTHER PERSON IN THE SITE. ANY SUCH REMOVAL MAY RESULT IN FURTHER ACTION INCLUDING, BUT NOT LIMITED TO, NO BULL JUST BEER & BIKES ISSUING SUCH PERSONS WITH A BAN PROHIBITING FUTURE ATTENDANCE AT THE SITE AND/OR LEGAL PROCEEDINGS BEING TAKEN.
